## Glossary of Terms

### **What is personal data?**

Personal data relates to any information about a human being that makes you identifiable which may include (but is not limited to);

- Full name
- Address
- Contact information (email address, telephone numbers)
- Previous address history
- Credit history information

### **What is sensitive personal data?**

Sensitive personal data is sometimes referred to as 'special categories of personal data'. Sudworth Accountancy Services Ltd will never ask you for sensitive personal data, the categories of this data are below;

- Racial & ethnic origin
- Political, religious and philosophical beliefs
- Trade union membership(s)
- Genetic & health data
- Biometric data
- Sexual orientation & sexual history

### **What is a Data Controller?**

For General Data Protection Regulation (GDPR) purposes, the "data controller" means the person, or organisation who decides the purposes for which personal data is processed and how it is processed.

### **What is a Data Processor?**

A “data processor” is a person or organisation which processes personal data for the controller.

### **What do we mean by Business to Business?**

PLC, LTD, LLP incorporated partnerships, trusts and foundations, local authorities and government institutions.

### **What do we mean Business to Consumer?**

Private clients, sole traders, unincorporated partnerships, trusts and foundations.

### **What information do we collect about you and how?**

Sudworth Accountancy Services Ltd, as a data controller is bound by the requirements of the General Data Protection Regulations (GDPR).

You agree that we are entitled to obtain, use and process the information you provide to us in order that we can provide you with our services and for other related purposes including;

- Regularly updating and enhancing client records
- Carrying out credit checks in relation to you.
- Legal and regulatory compliance
- Crime Prevention
- Statutory returns
- Analysis for management purposes

We collect information about you when you fill in any of the forms on our website, such as signing up for an event, filling in a survey, giving feedback or sending in an enquiry etc. Website usage information is collected using cookies.

When submitting forms on our website we use a third-party software provider for automated data collection and processing purpose, they will not use your data for any purposes and will only hold the data in line with our policy on data retention.

**Cookies** are text files put on your computer to collect standard internet log information and visitor behaviour information. This information is then used to track visitor use of the website and to create statistical reports on website activity. ### **Analytics** – eg how visitors use our website

We use Google Analytics to store information about how visitors use our website so that we may make improvements and give visitors a better user experience.

Google Analytics is a third-party information storage system that records information about the pages you visit the length of time you were on specific pages and the website in general, how you arrived at the site and what you clicked on when you were there. These cookies do not store any personal information about you eg name, address etc and we do not share the data. You can view their privacy policy below.

### **IP addresses**

An IP or Internet Protocol Address is a unique numerical address assigned to a computer as it logs on to the internet. Sudworth Accountancy Services Ltd do not have access to any personal identifiable information and we would never seek this information. Your IP address is logged when visiting our site, but our analytic software only uses this information to track how many visitors we have from particular regions.

### **Internet Based Advertising**

We use LinkedIn, Facebook and Twitter advertising services and as such there are tracking codes installed on our website so that we can manage the effectiveness of these campaigns. We do not store any personal data within this type of tracking

### **How will we use the information about you and why?**

At Sudworth Accountancy Services Ltd we take our privacy seriously and will only use your personal information to provide the services you have requested from us, detailed in your Letter of Engagement and supporting schedules as we have identified above. We will only use this information subject to your instructions, data protection law and our duty of confidentiality.

For Business to Business clients and contacts our lawful reason for processing your personal information will be “legitimate interests”. Under “legitimate interests” we can process your personal information if: we have a genuine and legitimate reason and we are not harming any of your rights and interests.

For Business to Consumer clients and contacts our lawful reason for processing your personal information will be “A contract with the individual” eg to supply goods and services you have requested, or to fulfil obligations under an employment contract. This also includes steps taken at your request before entering into a contract.

We may receive personal data from you for the purposes of our money laundering checks, such as a copy of your passport. This data will only be processed for the purpose of preventing money laundering and terrorist financing or as otherwise permitted by law or with your express consent.

Our work for you may require us to pass your information to our third-party service providers: subcontractors. However, when we use third-party service providers we disclose only the personal information that is necessary to deliver the services and we have contracts in place that requires them to keep your information secure and not to use it for their own direct marketing purposes.

We collect information on our website in order to process your enquiry and analyse survey results. If you agree to give your consent, we will also use the information to share updates with you about our services, which we believe may be of interest to you.

We will not share your information for marketing purposes with companies so that they may offer you their products and services.

### **Transferring your information outside of Europe**

As part of the services offered to you through this website, the information which you give to us may be transferred to countries outside the European Union (EU). Where this is the case we will take steps to make sure the right security measures are taken so that your privacy rights continue to be protected as outlined in this policy. By submitting your personal data, you are agreeing to this transfer, storing or processing. Where we deal with parties in the US we have ensured that their services fall under the Privacy Shield whereby participating companies are deemed to have adequate protection and therefore facilitate the transfer of information from the EU to the US.

If you use our services while you are outside the EU, your information may be transferred outside the EU to give you those services.

### **Security precautions in place about data collected**

When you give us personal information, we take steps to make sure that it's treated securely. Any sensitive information (such as credit or debit card details) is encrypted and protected.

Non-sensitive details (your email address etc) are sent normally over the internet, and this can never be guaranteed to be 100% secure. As a result, while we strive to

protect your personal information, we cannot guarantee the security of any information you transmit to us, and you do so at your own risk. Once we receive your information, we make our best effort to ensure its security on our systems. Where we have given (or where you have chosen) a password which enables you to access certain parts of our websites, you are responsible for keeping this password confidential. We ask you not to share your password with anyone.

### **How long will we hold your data for?**

Contracted Services: We will hold your data for 7 years in line with our regulatory requirements.

### **Access to your information, correction, portability and deletion**

#### **What is a Subject Access Request?**

This is your right to request a copy of the information that we hold about you. We will respond to your request within one month of receipt of the request.

#### **Objections to processing of personal data**

It is your right to lodge an objection to the processing of your personal data if you feel the “ground relating to your particular situation” apply. The only reasons we will be able to deny your request is if we can show compelling legitimate grounds for the processing, which override your interest, rights and freedoms, or the processing is for the establishment, exercise or defence of a legal claims.

#### **Data Portability**

It is also your right to receive the personal data which you have given to us, in a structured, commonly used and machine-readable format and have the right to transmit that data to another controller without delay from the current controller if:

- (a) The processing is based on consent or on a contract, and
- (b) The processing is carried out by automated means.
